Apart from being an academician she has worked as in-house counsel with a number of international law firms (Baker & McKenzie, Kyiv, Ukraine; Hanotiau & van den Berg (HVDB), Brussels, Belgium and Freshfields Bruckhaus Deringer, Paris, France). In addition, in 2010-2011 she was acting as a research associate for the interdisciplinary international investment arbitration project at the Private International Law Department of the University of Geneva Law School.

Currently, she is in charge of a number of law and dispute settlement related BBA, Undergraduate and MBA courses in several institutions in Switzerland: Business School Lausanne; European University (Geneva and Montreux Campuses); Hotel Institute Montreux; Northwood University (Swiss Campus). These appointments were preceded by a wide range of academic involvements with CEU in Hungary. She is also an author of a number of publications on international law and dispute settlement topics.
